NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2400, Houston, Harris County, Texas, said address being an office and meeting place of the District.

The meeting will be held on **Monday, October 16, 2023, at 10:30 a.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approve minutes of the Board of Directors meeting held on September 18, 2023;
3. Conduct a public hearing regarding the adoption of the District's 2023 tax rate;
4. Levy of the District's 2023 maintenance tax rate, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amended District Information Form;
6. Review and approve audit for fiscal year ended January 31, 2023;
7. Bookkeeper's report, including financial and investment reports and any actions required in connection therewith, and authorizing the payment of invoices presented;
8. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
9. Tax Assessor-Collector's report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
